Terminology	Description
Medication class	Medication with similar chemical structures or similar therapeutic effects.
Reference Price	The Reference Price is the set monthly amount we pay up to for a medication category. This applies to medication that is not listed on the medicine list.

Estrofem 2mg	Estrogens
Activelle	Progestogens and estrogens, fixed combinations
Novofem	Progestogens and estrogens, sequential preparations
Provera 5mg	Progestogens - Pregnen (4) derivatives
Provera 10mg	Progestogens - Pregnen (4) derivatives
